Guarantor further waives notice of acceptance of this guaranty and consents to all changes of terms, extensions of credit, and any extensions or forbearance by Franklin. Notwithstanding the foregoing, Franklin, by its acceptance hereof, hereby agrees that it will not take any action to collect on this Guaranty until it has first given at least thirty (30) days prior written notice to Guarantor.

Guarantor agrees to pay Franklin reasonable attorney fees and all other costs and expenses that may be incurred by Franklin in enforcement of this guaranty. The Guarantor hereby consents to Franklin's use of consumer credit reports on the Guarantor in order to further evaluate the creditworthiness of the Guarantor as a principal, proprietor and/or Guarantor in connection with the extension of credit to Company. Guarantor hereby authorizes Franklin to utilize a consumer credit report on the Guarantor from time to time in connection with the extension or continuation of credit extended to Company.
